MASKS:

- Everyone is required to wear a mask throughout the facility except when actively engaged in physical activity (coaches on the bench need to be masked); or when <u>seated</u> at a table in the concession or lounge.

DRESSING ROOMS:

- There is limited capacity in the dressing rooms (7 participants and one standing coach); it is recommended participants come dressed and ready to play. Masks are required by everyone in dressing rooms.

ON-ICE AND DRYLAND ACTIVITIES:

PARTICIPANTS:

- Youth participants aged 17 years and younger do not need to provide proof of vaccination, a negative COVID-19 test, or a medical exemption. Youth participants not providing proof must vacate the facility immediately upon finishing their activity.
- **Adult participants** aged 18 and older (**including coaches, volunteers, support personnel**) are required to provide one of the following to participate in activities:

1. <u>Proof of vaccination:</u>

- Valid photo identification that matches vaccine records;
- Valid paper or digital vaccine record that show name, vaccine type, and date of administration;
- September 20 to Oct 25, proof of single dose;
- After October 25, proof of double vaccination.

2. Proof of a negative COVID-19 test:

- Test results must be within 72 hours prior to the activity;
- Valid test results should be a written or printed copy that clearly outlines the type of test, time of sample collection, clear indication of a negative result, and the laboratory that completed the test, if applicable;
- Photos of a rapid test result taken offsite is not sufficient;
- A self-test completed offsite, or self-produced documentation of a negative test result, is not valid;
- Tests must not be from Alberta Health Services public COVID-19 testing system;
- Do not bring completed self-tests to SPFAS due to communicable disease risk.

3. Documentation of a medical exemption:

- A valid medical exemption is the original signed letter from a physician or nurse practitioner that includes person's name that matches their identification and physician's or nurse practitioner's complete information, including:
- name, phone number, contact information, professional registration number and signature;
- statement that there is a medical reason for not being fully vaccinated against COVID-19;
- duration that the exemption is valid.

SPECTATORS:

- **All spectators 12 years and older** are required to provide proof of vaccination, a negative COVID-19 test, or a medical exemption as listed in 1., 2., and 3. above, accompanied with photo identification (for adults 18+).

CONCESSION & LOUNGE:

- Lounge: All persons 12 years and older are required to provide proof of vaccination, a negative test, or a medical exemption as listed in 1. 2. or 3. above, accompanied with photo ID (for adults 18+) to use the Lounge; curb side service will be provided.
- **Concession:** An update will be provided shortly.

BOARD ROOM:

- **All persons 12 years and older** are required to provide proof of vaccination, a negative COVID-19 test, or a medical exemption as listed in 1., 2., and 3. above, accompanied with photo ID (18+) to access the Board Room.
